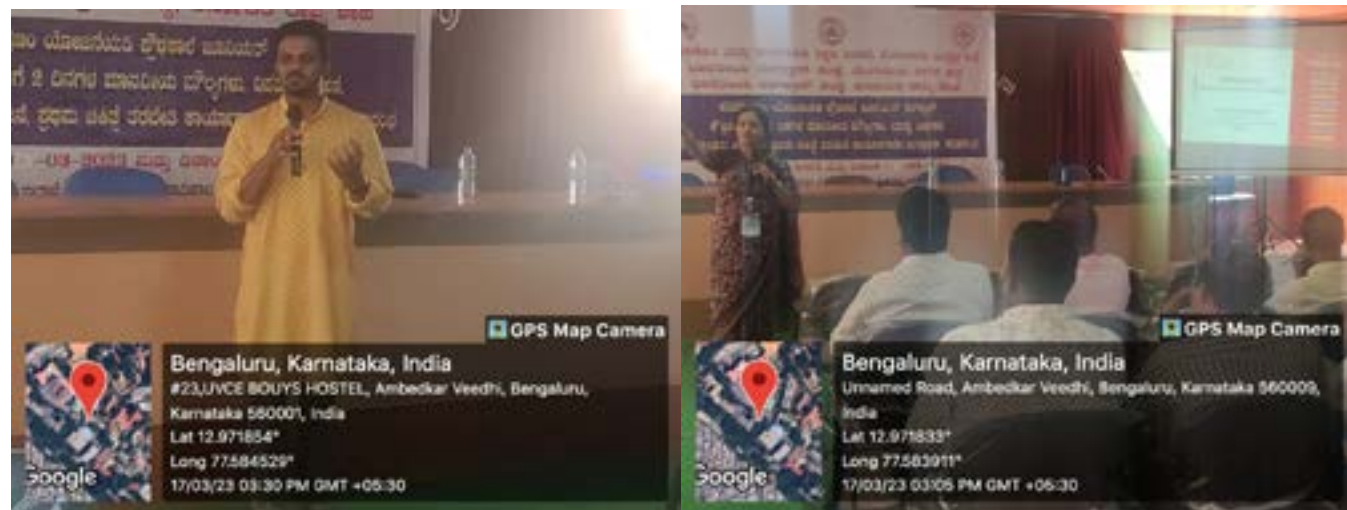

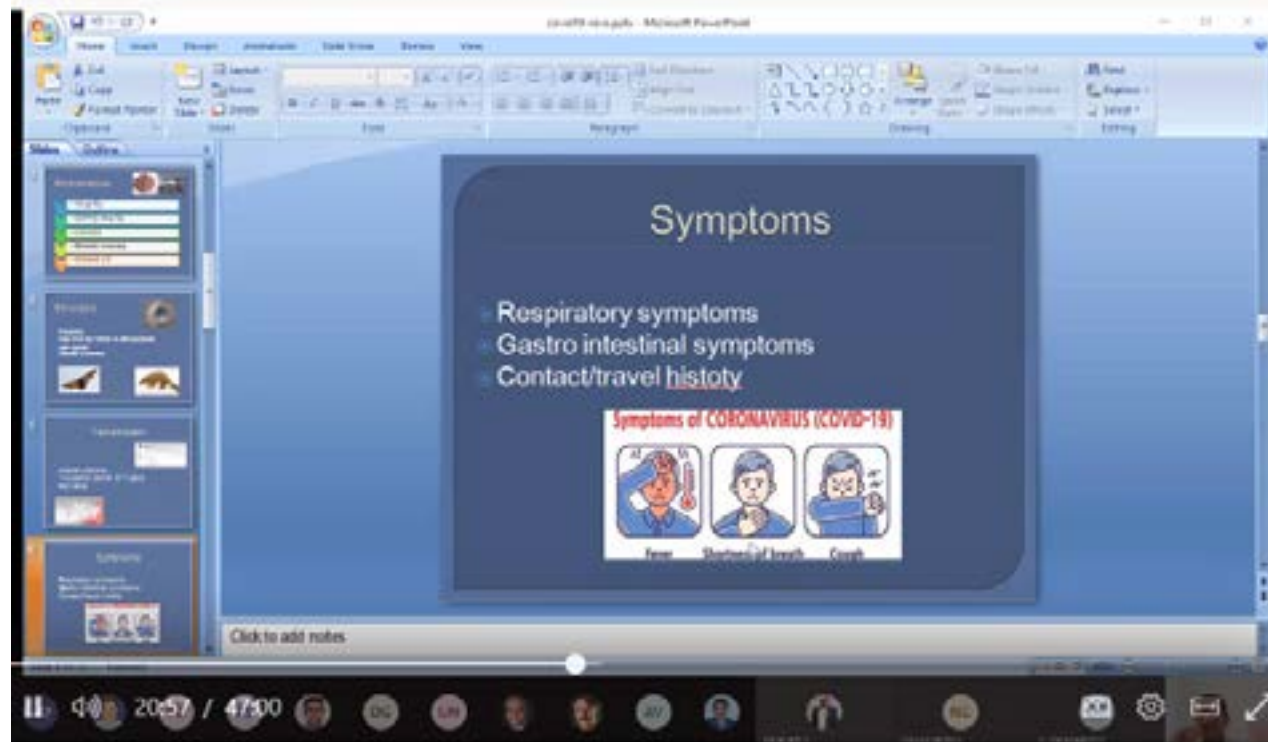

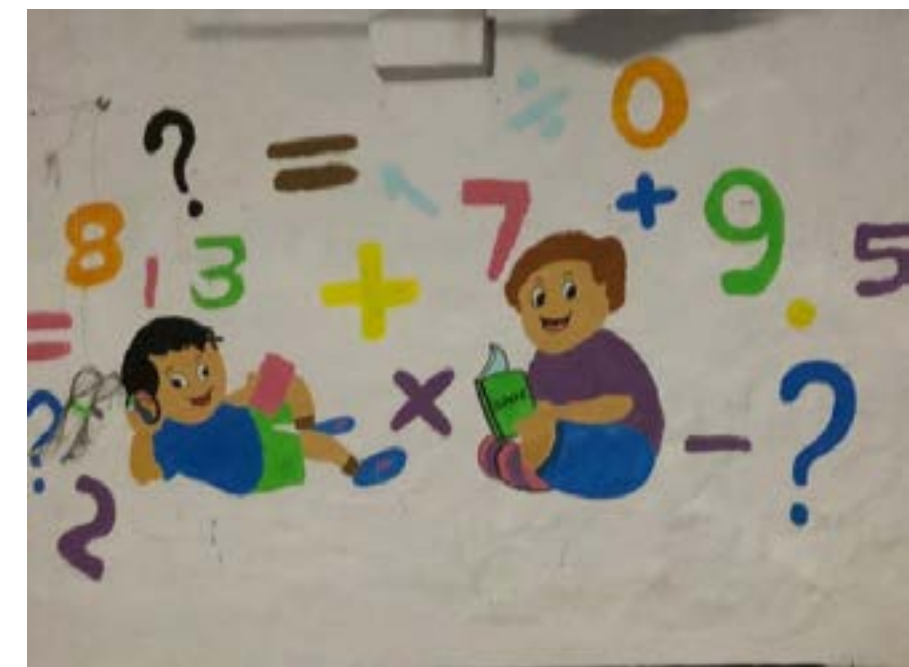


Community Outreach Program at Bangalore rural area, Devanahalli Taluk

The School of Architecture, REVA University in collaboration with Campus 2 Community organised a community outreach program from 20th to 23rd September 2019 at Channarayapatana , Naganayakanalli , Janatha colony , Channahalli , Jalige , Rajagatta , Beer Sandra and Tinglu village. In collaboration with Art Matters and students from various colleges, Campus 2 Community organised "SCHOOL BELL," a mass service project that remodelled 150 government schools in remote rural villages bordering Bengaluru to commemorate Mahatma Gandhi's 150th birthday. - Since Cataract is the major cause of blindness, our main objective of conducting eye camps is to identify people with cataract and provide them with the necessary treatment, that is surgery.
- To detect Glaucoma cases and manage by routine tonometry and in suspected and proven cases of Glaucoma, to refer them to the base hospital for treatment.
- To prescribe glasses for refractive errors.
- To detect and treat (operate when required) diseases such as pterygium, chronic dacryocystitis and other infections.
- To undertake health education of the community on proper care.
- To develop and maintain relationship with the community.

Event Outcome:

- Increased student involvement in social activities
- Big help for people who depend on free eye check-up and operation camps.
- Took count of people who need to undergo cataract operation or other eye check-ups in the months.
- Sankar Eye Hospital provided spectacles and medicines free of cost

Description of Event:

Abhivridhhi

REVA University has partnered with the Government of Karnataka to develop and impart quality education at lower and higher primary government schools, through its CSR initiative 'Abhivridhhi'.

As part of this initiative, REVA has adopted 10 government schools located around Bengaluru North (Yelahanka and Devanahalli constituencies) in the fringes of the city.

The pilot of 'Abhivridhhi' was launched in August 2020 and the core committee members of Abhivridhhi have conducted several in-depth surveys over the last five months to ascertain the requirements, challenges, and other details of the adopted schools.

'Abhivridhhi' is launched with a mission to aid quality education at government schools and aims to overhaul the learning experience at these schools. Currently, around 1000 students are learning in these schools, but due to the closure of schools as a COVID-19 protocol, have remained home during the pandemic.
