Legal Aid outreach program

School of Legal Studies, REVA University has attempted a Legal Aid outreach program on village survey at Kommasandra village, Devanahalli, Taluk, Bangalore Rural District on 11.1.2020 by visiting door to door and got the data on the classes of personal information and family information of the Houses including Domestic information, Village information, and village issues/ problems through the agenda design. The 68 law students have taken an interest in this occasion. The students procured information on social concerns and the spirit of the village culture and they roused to take up the difficulties to take care of the issues confronting society.

Conferring legitimate mindfulness was the primary target of this outreach program. The group interfaced with individuals from the village and gathered information and sources of info in regards to the issues that existed and made mindfulness on the legal services accessible so it enables them to use them at their will. Some of the main concerns voiced by the villagers were proper roads, water, drainage, transport, Grama Sabha, and health care centers to be built. Law students additionally associated with Advocate and Gram Panchayath Mr. Ramanjanaiah K.H and another Gram Panchayat Member N. Manjunath, from the same village concerning different legal issues and the difficulties that existed in the village. With everything taken into account, the program and survey were worthwhile as the students as well as the Professors got knowledge into the issues looked at by regional India which would empower them to usefully move in the direction of resolving them.

Dr. Nagaraja V, Professor, who is the Co-ordinator of REVA Legal Aid Clinic guided the students to carry out this outreach program in a methodical way. Prof. Venkataswamy, Assistant Professor of the School of Commerce and Management Studies of REVA University supported this program. The faculty of Prof. Raghavendra G., Pallavi Sen, Dr.Kumara J N, and Prof. Soujanya encouraged the students during the visit.

Inauguration of REVA Legal Aid Clinic

Mr.Hanchate Sanjeeva Kumar Hon'ble Member Secretary, Karnataka State Legal Services Authority, inaugurated the REVA Legal Aid Clinic on 24th April 2019. The inaugural function was attended by Dr.P.Shyama Raju Hon'ble Chancellor, REVA University,the Guest of Honor Dr.S.Y.Kulkarni Vice chancellor, REVA University and Dr. M. Dhanamjaya Registrar, REVA University graced the occasion, the Keynote Address was delivered by Mr.Aswatha Narayana, Chairman, and Permanent Lok Adalath addressed the gathering. The program began with the invocation song by Srishti Sarkar student of IV Semester BA LL.B, the Guest was welcomed by Director of School of Legal Studies, Dr. Kalicharan M. L., and the inaugural function was attended by faculty and students. The Memorandum of Understanding was signed between REVA University and Karnataka State Legal Services Authority, Bengaluru to set-up REVA Legal Aid Clinic at REVA University, Bengaluru.

Mr.Hanchate SanjeevaKumar declared open the clinic at the School of Legal Studies, REVA University, In his address, Mr.Hanchate Sanjeev Kumar said the main objective of opening the clinic was to provide legal assistance and guidance to the poor and downtrodden who could not afford to engage lawyers or move courts to assert their rights and redress their grievances.

In order to make them aware of their rights and equip them to avail the benefits of the different social welfare activities sponsored by the State and Central Government, the REVA Legal Aid Clinic has been established at REVA University. Dr.Nagaraja V is the co-coordinator for the REVA legal aid clinic who is organized the event.

Dr.P.Shyama Raju Hon'ble Chancellor, REVA University in his Presidential address called upon the students to spread legal awareness among the public by organizing awareness camps, seminars, debates, legal counseling sessions and street plays. He also asked the students to provide a people-friendly environment at the clinic

The Guest of Honor Dr.S.Y.Kulkarni Vice chancellor, REVA University,emphasized that the clinic had been opened to help students to understand the problems faced by the people and enlighten them about their rights and provide remedies under law.

Mr.Aswatha Narayana, Chairman, and Permanent Lok Adalath will address the students and faculty, he quoted free legal aid services such as legal advice, legal representation and legal adjudication free of cost. Patients seeking treatment at the hospital can utilize free legal aid. Person with disabilities can assert their rights using such clinics in matters such as disability certification, employment and pension. They can also defend their rights regarding admission to hospitals, human rights violation, treatment, property issues and marital issues. Women can be helped in issues like, sexual violence, domestic violence and other property related issues.

INDUCTION PROGRAM for PLVs on the Awareness of legal services

School of Legal Studies organized Induction Program for Students Volunteers, on 29th April 2022, the program organized in association with Karnataka State Legal Services Authority, Bengaluru, the induction program will provide a legal exposure to the students. The program was graced by Hon'ble Sri.H.Sashidhara Shetty, District Judge, Member Secretary, Karnataka State Legal Services Authority, Hon'ble Sir. Vignesh Kumar, Senior Judge, PRO, Karnataka State Legal Services Authority and Dr.Bharathi.S, Director School of Legal Studies, REVA University, on the occasion Hon'ble Sri.H.Sashidhara Shetty, District Judge, Member Secretary, Karnataka State Legal Services Authority spoke about access to justice for all, particularly the poor, marginalized and disadvantaged, is essential for maintaining the rule of law in a democratic society. Article 14 of the Constitution obliges the State to guarantee all its citizens equality before the law and a legal framework that ensures justice based on equal opportunity for all. It is against this background that the Indian Parliament enshrined free legal aid as a directive principle under Article 39A of the Constitution in 1976. The enactment of the Legal Services Authorities Act in 1987 and the subsequent establishment of NALSA in 1995, this concept was given a statutory foundation. It has since been regarded as a became one of hope for the underprivileged. However, it is riddled with significant complexities that hinder it from reaching its full potential, and the underprivileged from being denied access to quality justice the involvement of law schools in the justice delivery process. Since its inception in the 1970s, legal aid has yet to be fully incorporated into India's clinical legal education.

On the hand Hon'ble Sir.Vignesh Kumar, Senior Judge, PRO, Karnataka State Legal Services Authority, Sir spoke about the role of, State Legal Services Authority which has been constituted to give effect to the policies and, as per the directions of the **NALSA** and to give free legal services to the underprivileged section of the society people and even the Lok Adalat's in the State. The State Legal Services Authority is headed by Hon'ble the Chief Justice of the respective High Court who is the Patron-in-Chief of the State Legal Services Authority.

In every District, District Legal Services Authority has been constituted to implement Legal Services Programs in the District. The District Legal Services Authority is situated in the District Courts Complex in every District and chaired by the District Judge of the respective district. Sir also emphasized onsignificances of human rights issues included: unlawful and arbitrary killings, including extrajudicial killings perpetrated by police; torture and cases of cruel, inhuman, or degrading treatment or punishment by some police and prison officials; arbitrary arrest and detention by government authorities; harsh and life-threatening prison conditions; political prisoners or detainees in certain states; restrictions on freedom of expression and the press, including violence, threats of violence, or unjustified arrests or prosecutions against journalists, use of criminal libel laws to prosecute social media speech, censorship, and site blocking; overly restrictive rules on nongovernmental organizations; restrictions on political participation; widespread corruption at all levels in the government; lack of investigation of and accountability for violence against women and forced and compulsory child labor, as well as bonded labor. The free legal aid will be provided for socially and economically vulnerable people was introduced across India in 1995, when the Legal Services Authorities Act came into force. The law is aimed at ensuring justice for all based on equal opportunity, and one its key provisions mandates offering free services of lawyers who volunteer their time for pro bono cases to those who cannot afford to pay.

Hon'ble Sir.Vignesh Kumar, Senior Judge, PRO, Karnataka State Legal Services Authority, underlined the need to recruit more lawyers for the program. "The strength of our para legal and lawyers is not enough for a state or city, and we do send out appeals to the Bar Associations, Law Universities and Law Colleges to conduct meetings with them to get more lawyers and law students," he said. "But, at the end of the day, lawyers and students are volunteering with

us so we cannot compel them to have feelings of reciprocating to society."

Prof Dr.Nagaraja.V, Co-ordinator of REVA Legal Services Clinic also spoke about the role of REVA Legal Services Clinic and it's essential that volunteers need to be involved in best planned and executed community-based programs These plans must be well designed by the school volunteers which will in turn help underprivileged in their development and provide the assistance in concerned to the downtrodden community help in the reformation and rehabilitation. These community-based program may range from training programs, festival celebrations, workshops relating to dance drama and coaching etc. active participation from both sides will help the community.

The program began with the invocation song by Prof Meera B. Latha and the program compering by Prof.Sriranagam Muralidhar Soujanya. The indication program was conducted under the able guidance of Hon'ble Chancellor Dr.P.Shyama Raju, Hon'ble Vice Chancellor Dr. M.Dhanamjaya and Dr. Bharathi S., Director of School of Legal Studies, Reva University.









OUTREACH PROGRAM – Door to Door survey in the village

School of Legal Studies organized a village survey at Hunasamaranahalli Bengaluru Urban Zilla Panchayat on **27th August 2022**. This camp was organized as an initiative by REVA Legal Services Clinic which conducted a socioeconomic survey. Thirty-two students of Team -2, under the guidance and supervision of Dr.Nagaraja V, Professor and Co-ordinator of REVA Legal Services Clinic. The Assistant Professor Raghavendra.G is the team supervisor.

The team reached the venue which was Hunasamaranahalli Bengaluru Higher Government School and began with an introduction and interaction with Headmistress. Gram Panchayat member Dr.H.B.Harish Babu apprised the team that the village consisted of two thousand house as of now completely urbanized because connectivity to international airport. The team then divided themselves into 16 groups with three members in each group and conducted the survey. Imparting legal awareness was the main objective of this camp. The team interacted with people from the village and gathered information and inputs regarding the problems that existed and created awareness on the legal services available so that it empowers them to use at their will. Some of the main concerns voiced the villagers were proper roads, transport, and healthcare centers to be established. Law students also interacted with residents of the village regarding various legal issues and the challenges that existed in the village. In the camp and survey was worthwhile as the students as well as the faculty got an insight into the problems faced by rural with (semi-urban) India which would enable them to constructively work towards resolving them. This Camp and Survey was conducted under the able guidance of Hon'ble Chancellor, Vice-Chancellor and Dr. Bharathi S, Director of School of Legal Studies, Reva University.





Establishment of REVA Legal Services Clinic at Hunasamaranahalli on 22.11.2022 for rural services

Karnataka State Legal Services Authority in collaboration with School of Legal Studies, REVA University conducted program, in concern to inaugurating the new premises at Hunasamaranahalli on 22nd November 2022, the new premises was inaugurated by Hon'ble Sri. Jaishankar, District and Session Judge, and Members Secretary, KSLSA, Dr.Bharathi S, Director School of Legal Studies, and Members of Bengaluru Purasabe, Hunasamaranahalli were present on the occasion. The Hon'ble Sri. Jaishankar, District and Session Judge, and Members Secretary, KSLSA, speaking on the occasion Hon'ble Judge, mention the importance of legal services clinic and role in nation building, further Hon'ble Judge highlighted the place of legal aid in the Directive Principles of the State Policy. This importance is reflected in the faith of the citizens in the Judiciary of the country. Hon'ble Judge once again raised the issue of sensitivity towards undertrial prisoners. He said that the District Legal Services Authorities will provide legal aid to undertrial prisoners. He also appealed to the para legal volunteers, facilities, and Director of Legal Studies to conduct legal aid service for undertrial, to expedite the release of undertrial prisoners. The Hon'ble Judge complimented School of Legal Studies, REVA University for undertaking in providing legal aid service to the underprivileged.

In the Presidential address Dr.Bharathi.S, Director, School of Legal Studies, REVA University, she said that the REVA Legal Services Clinic will take up the responsibility of providing legal aid to under trial prisoners and underprivileged community in the society.

Mr. Abhay Choudhary. M, Student-PLV ninth semester, spoke about the importance of legal services association and about its activities. Further he spoke about the roadmap of legal services clinic. The Program began with invocation song by Miss.Kavya Nayar, Student-PLV, and the vote of thanks was proposed by Miss.Akula Supriya- Student-PLV. Program was conducted under the able guidance of Hon'ble Chancellor, Vice-Chancellor, and Pro.Vice-Chancellor's.

SYMPOSIUM on Eradication of Gender Based violence for villagers at Sonnappanahalli on 25.2.2023

School of Legal Studies, REVA University, conducted one day Symposium, in concern to Gender Based Violence and its Eradication at Sonnappanahalli Higher Government Primary School on 25th February 2023, symposium conducted for the Public, Higher School students, Teaching staff and Non-teaching staff, faculty from the School of Legal Studies consisting of Prof Sreevidya K.V., Prof Raghavendra G, Dr.Yashwant Singh and Students and volunteers of para legal services of REVA Legal Services Clinch Miss Shivani, Mr. Sushil and Mr.Brucelee Rambo were the part the team.

Prof Sreevidya K.V, spoke about, gender, gender equality and inequality, problems of gender inequality, major reasons for gender discrimination, sexual harassment at workplace, sexual harassment prevention at workstation, later she spoke the sensitivity has been felt and need to be realized through times immemorial and in almost all kinds of human existence, across the globe. Recent discourses focus upon the need to sensitize gender issues in society and as many believe that education is the catalyst for change. The educational spaces instill thought and make one have a perception that the society believes. the help of education, gender sensitization in educational institutes can create awareness among the students and other members of the community about their roles in future as the men and women in the society. She also spoke on the various Articles and provisions in the Indian Constitution which protects women, people with disabilities, transgender people, and other minority communities. She began with introducing women freedom fighters and visionaries of women's rights who were part of the social reform movements and the women's movement in India and who also actively contributed to the drafting of the Indian Constitution.

Audience also addressed by Prof.Raghavendra G, who provided an overview of the various laws in the Indian Penal Code (IPC) related to crimes against women and discussed on other special laws for women. She underlined how crimes against women are also a violation of the right to life. He also spoke about Prevention of Sexual Offences against Children Act 2012, and the Domestic Violence Act. He elaborated on the laws, in align to sexual harassment of women at the workplace. He also emphasized that it was only after the Criminal Law Amendment Act 2013 the definition of rape and the concept of consent was expanded from its earlier narrow and stereotypical definitions. Further the Criminal Law Amendment Act 2013 for the first-time recognized voyeurism, stalking and acid attack as crimes against women. He concluded that the law should also consider caste, class, religion and other cultural realities and the need to include gender component to be integrated in regular course.

Assistant Head Mistress. Mrs. Anita highlighted the various ways in which women and girls are being harassed and emphasized the need for gender sensitization especially for young children starting from the school level. she provided several suggestions to promote gender sensitivity in the school environment to educate and inculcate gender sensitivity right from childhood. This event is organized under the guidance of Dr.Nagaraja V coordinator, REVA legal services clinic.

The workshop began with invocation song by Miss.Sudha, Student-of VIII Standard, Sonnappanahalli Higher Government Primary School, and the vote of thanks was proposed by Miss. Shivani of VI Semester BA LL.B(H) workshop conducted under the able guidance of Hon'ble Chancellor, Vice-Chancellor, Pro.Vice-Chancellor's and the Director of School of Legal Studies





1.Number of volunteers in Reva legal aid:-




