**Brief about the activities held-**The Workshop on “Bridging Justice: Juvenile Rights and Legal Aid”, organized by the REVA Legal Services Clinic *in collaboration with Komal C (Alumni 2023 Batch) working in JustitiaPsyche (NGO)*, was held on 22nd May 2025, from 10:00 AM to 1:00 PM. 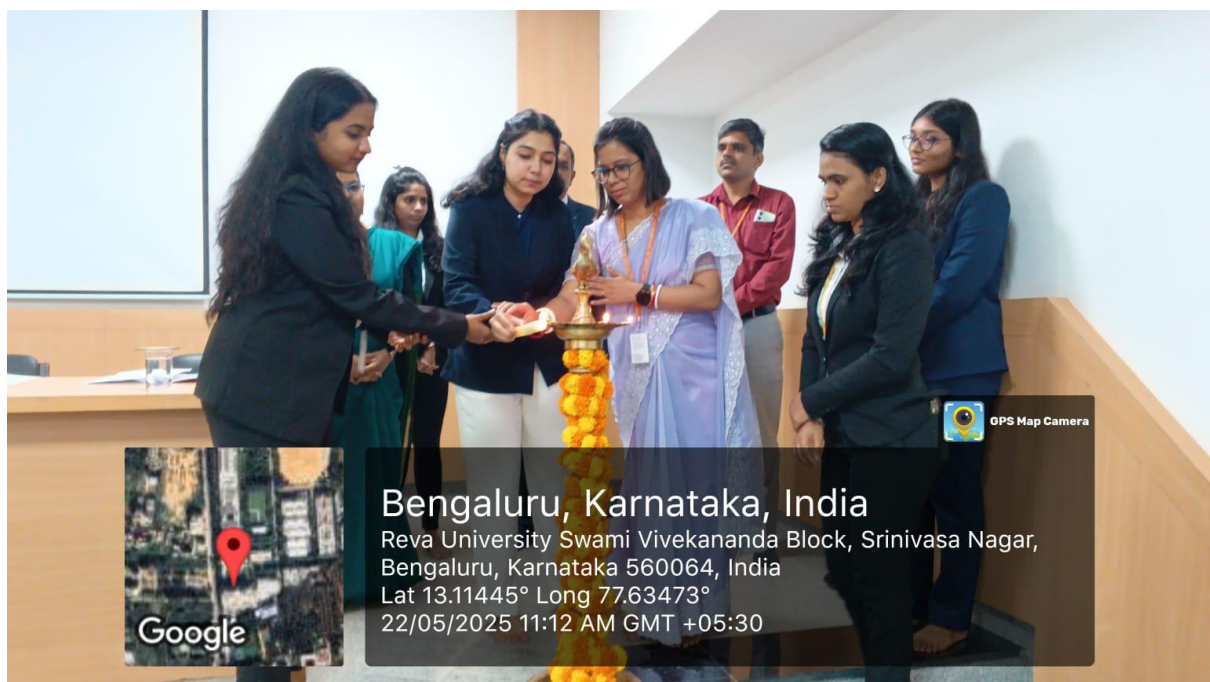
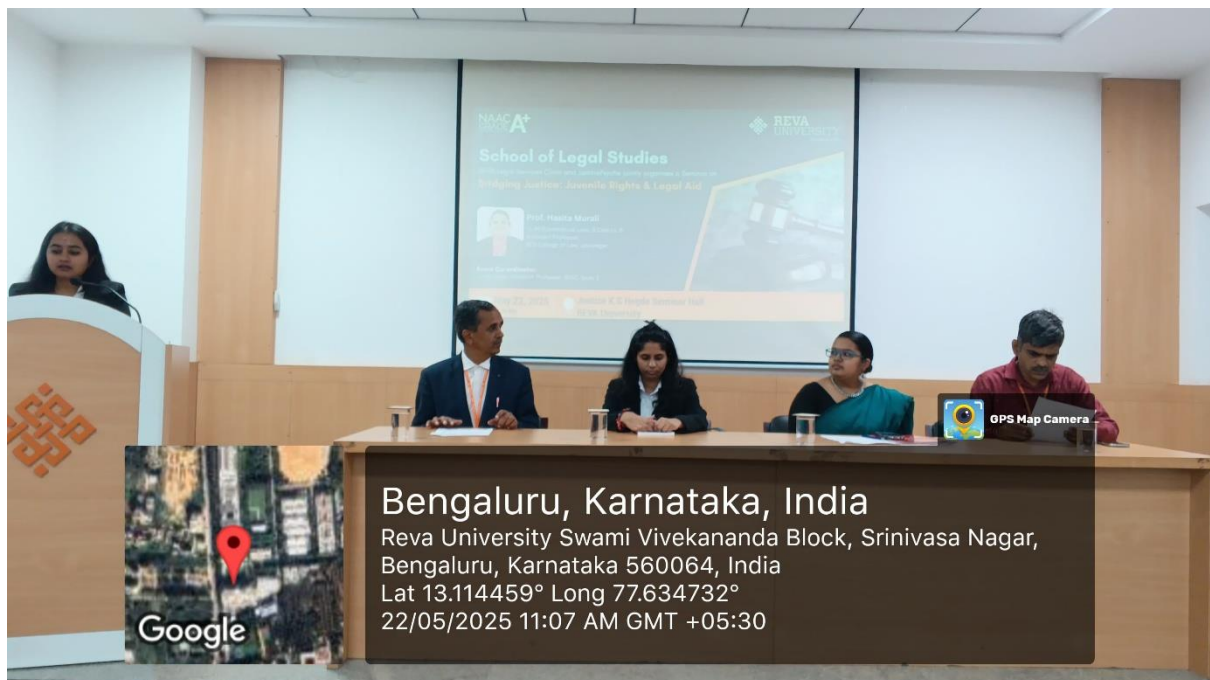




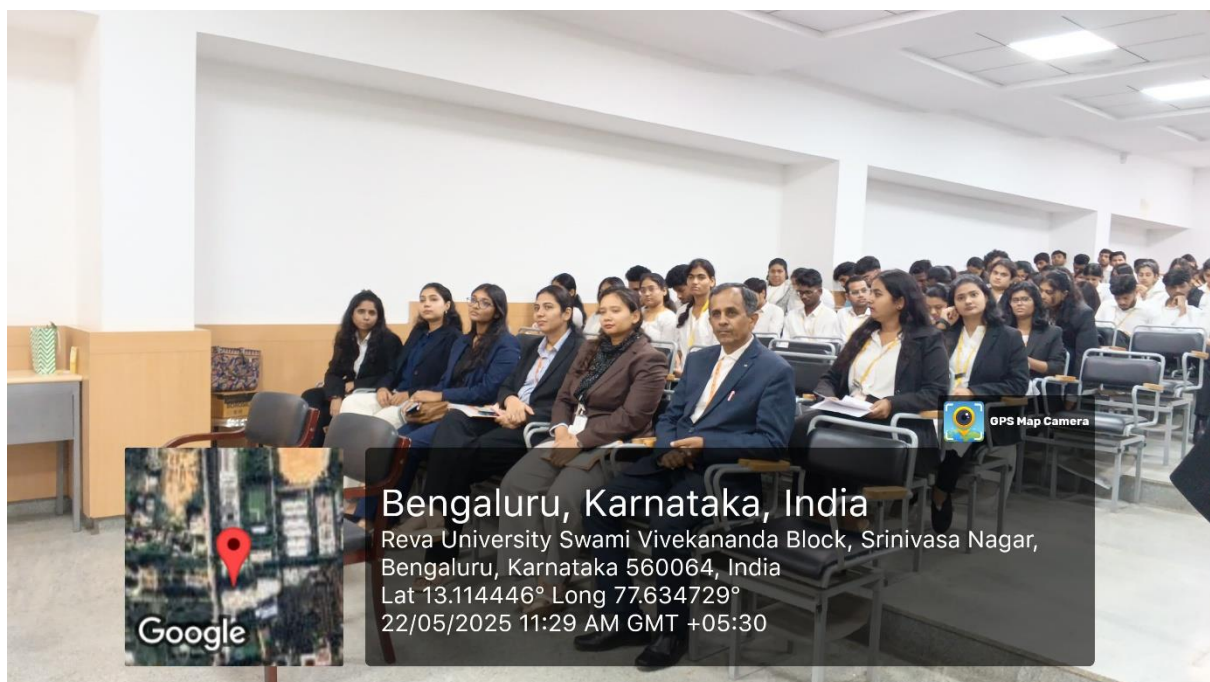
