# **About the Faculty Development Program**

The Faculty Development Program (FDP) on "Comprehending the new Criminal Laws; BNS and BNSS, & BSA and their impact on the legal education system" is designed to equip faculty members and researchers with the tools, techniques, and strategies required to excel in application of criminal law. The recent overhaul of India's criminal justice system with the introduction of the Bharatiya Nyaya Sanhita (BNS), Bharatiya Nagarik Suraksha Sanhita (BNSS), and Bharatiya Sakshya Adhiniyam (BSA) marks a historic shift from colonial–era laws to indigenous, victim–centric frameworks. BNS replaces the IPC, BNSS substitutes CrPC, and BSA modernizes the Evidence Act. These reforms emphasize speedy justice, forensic support, and digital evidence integration. For legal education, this transformation demands immediate curriculum revision, pedagogical shifts, and faculty upskilling. Law faculties must now focus on comparative analysis, practical training, and interdisciplinary approaches.

FDPs play a pivotal role in equipping educators to navigate these changes effectively and deliver relevant, future-ready legal education. Experts from various domains will guide attendees through practical sessions, giving them insights into the application of criminal law.

#### **Objective of the Programme**

- 1. To familiarize faculty members with the key provisions and structure of the Bharatiya Nyaya Sanhita (BNS), Bharatiya Nagarik Suraksha Sanhita (BNSS), and Bharatiya Sakshya Adhiniyam (BSA), 2023, replacing IPC, CrPC, and Indian Evidence Act respectively.
- 2. To enable in-depth understanding of the philosophical and jurisprudential foundations behind the enactment of these new criminal laws and how they reflect contemporary societal needs.
- 3. To facilitate comparative analysis between the old and new criminal legal frameworks, highlighting significant shifts in definitions, procedural mechanisms, evidentiary rules, and penal provisions.
- 4. To train faculty in critically examining the constitutional, human rights, and federalism implications of the new criminal law regime.
- 5. To explore the pedagogical shifts required in the teaching of criminal law in light of the new statutes, including curriculum restructuring and integration of case law and critical scholarship.
- 6. To equip faculty with research methodologies and tools to engage in academic scholarship focused on BNS, BNSS, and BSA, and promote interdisciplinary research on criminal justice reforms.
- 7. To assess the impact of the new laws on legal education policies, academic resources, and law school assessments, ensuring alignment with the new legal reality.
- 8. To promote collaboration among law faculties and stakeholders in the justice system (judiciary, police, bar) for effective dissemination and discussion of the reforms.
- 9. To encourage experiential learning models, including moot courts, mock trials, and clinical legal education that reflect the procedural and evidentiary changes under BNSS and BSA.
- 10. To examine the role of technology and digital evidence as emphasized in the new laws, and train faculty to incorporate these aspects into teaching and research.
- 11. To foster critical engagement with the socio-legal impact of the reforms on marginalized communities, gender justice, and access to justice.
- 12. To build faculty capacity for continuous legal education and outreach, ensuring that law educators become change agents in the transition to the new criminal law framework.

## **Outcome of the Program**

1. Comprehensive understanding of BNS, BNSS, and BSA:

Faculty members will gain a clear and structured understanding of the provisions, terminology, and scope of the new criminal laws replacing IPC, CrPC, and the Indian Evidence Act.

2. Enhanced jurisprudential insight and legal interpretation skills:

Participants will develop the ability to analyze the philosophical and social context of the criminal law reforms and apply that understanding in academic discussions and legal reasoning.

3. Ability to undertake comparative legal analysis:

Faculty will be equipped to compare old and new legal provisions effectively, helping students and institutions transition smoothly to the updated legal framework.

4. Integration of constitutional and rights-based perspectives:

Faculty will be capable of evaluating the constitutional implications, including federal principles and human rights issues, embedded in the new laws.

5. Reformed teaching methodologies and curriculum planning:

Educators will be prepared to revise existing syllabi, incorporate updated case studies, and implement pedagogical innovations suited to the new legal system.

6. Strengthened research and academic writing competencies:

Participants will be able to design and pursue research projects on the impact and effectiveness of the new criminal laws, contributing to legal scholarship and policy discourse.

7. Institutional readiness for legal education reform:

Law schools will benefit from faculty capable of aligning institutional policies, teaching materials, and assessment strategies with the new legal regime.

8. Improved collaboration with justice stakeholders:

Faculty will be able to establish and strengthen partnerships with the judiciary, legal professionals, and enforcement agencies to ensure a well-rounded understanding and dissemination of the reforms.


